# ANU Centre for European Studies–ABC Radio National: Big Ideas from Europe

#### Big Ideas Panel Discussion - Nordic Noir, 12 July

ANUCES, together with the 2017 Volvo Scandinavian Film Festival, presented a Nordic Noir Panel Discussion, chaired by ABC's Kate Evans.

The discussion took place after the screening of Danish film *A Conspiracy of Faith* at the Palace Verona, Sydney. It was a fantastic Q&A on Scandinavian crime fiction with an exceptional line up of panellists, including the Scandinavian Film Festival Guest and director of *The Man*, Charlotte Sieling. Also on the panel were Hanna Lofgren and Susan Turnbull.

## Paul Gretton at the G20 Trade Conference and the University of Oxford

Paul Gretton, ANUCES Visiting Fellow and Visiting Fellow at the East Asian Bureau of Economic Research, Crawford School of Public Policy, undertook a fruitful visit to the University of Oxford in June. It was an extension to Paul representing ANU at the G-20 Trade Conference at OECD Paris Headquarters. Paul presented on the topic 'Distributing the Gains from Trade'.

At the University of Oxford Paul was hosted by Professor David Vines, Acting Director of the Program on the Political Economy of Financial Markets (PEFM). During his visit Paul presented a PEFM seminar on 'Bilateral and Regional Trade Agreements: A Case for Economic Reform?' and undertook advance planning with David Vines towards further work on Brexit. Officials at HM Treasuring, the Bank of England and the Australian High Commission were approached to canvas interest in such a meeting. Paul was involved in positive discussions with each of the groups visited, including some vigorous quizzing on the implications of alternatives.

## Jason Ji Xianbai completes Europa Fellowship with a public lecture

Jason Ji Xianbai is a PhD Candidate at Nanyang Technological University, Singapore, and former ANUCES Europa Visiting Fellow. Jason presented a public lecture at the Centre entitled 'Navigating the Convoluted Trade Architectures: "Preference Ordering" for Australia and Post-Brexit UK'.

The lecture explored how the proliferation of overlapping megaregional trade agreements has transformed the global trade landscape from one characterised by a clearcut choice between regionalism and multilateralism, to one that is defined by the complex interplay among multiple trade regimes, with outcomes shaping and reshuffling government's trade policy preferences.

# **Brett Lidbury to visit Radboud University, The Netherlands**

ANUCES Associate Dr Brett Lidbury from the National Centre of Epidemiology and Population Health (NCEPH) will join colleagues at Radboud University, Nijmegen, The Netherlands, to extend their research relationship and explore joint educational opportunities for the future. The areas of research expertise central to this visit are systematic review (SR) and other methods available that support the emerging academic area of 'synthesis-of-evidence'. These methods can be broadened to other areas of interest within biomedical/medical research, including the identification of disease/toxicity mechanisms and pathways, which can therefore also assist with animal replacement and reduction strategies for experimentalists. Together with his Dutch and Australian colleagues, Brett has been successful in attracting funding via the Erasmus Scheme in the Netherlands to support future staff and student exchange on the topic of SR and related research methods.

# John Besemeres guest of honour at Polish Constitution Day event

ANUCES Research Fellow Dr John Besemeres was this year's guest of honour and speaker at the Polish Constitution Day Commemorative Dinner in Melbourne. The Dinner has taken place annually since the inaugural event in 2002, featuring a different guest speaker each year. Guest speakers from previous years have included former Governor of Victoria Sir James Gobbo AC CVO QC; former Chief Justice of the High Court of Australia The Hon Murray Gleeson; former Prime Minister of Australia The Hon Tony Abbott MP; Professor Norman Davies; international concert pianist Roger Woodward AC OBE; former Deputy Prime Minister, Ambassador to the Holy See The Hon Tim Fischer AC; and Brigadier Gary Hogan AM, CSC.

Patrons for the 2017 Dinner included the Ambassador of the Republic of Poland in Australia, His Excellency Paweł Milewski; Honorary Consul General for the Republic of Poland in Victoria Dr George Luk-Kozika OAM; and former Prime Minister of Australia The Hon Kevin Rudd. The Australian Institute of Company Directors commented that John's lecture was perhaps the 'best address ever', giving background to what is behind the headlines, in a historical world context. Protecting the environment is a key issue for Russia, with its vast wilderness areas and its economy's reliance on extractive

industries, which have the potential to cause massive pollution.

This book explores how policymaking works in Russia, focusing on the important field of environmental policy. Ellie argues that, contrary to the prevailing view that the presidency dominates the policy process, with Putin making all major decisions or at least being the arbiter between conflicting parties, policy is in fact made by a range of competing interests including the bureaucracy and influential industry and industrial association lobbvists, with relatively little intervention from Putin. The book shows how, although Russia does not have a strong civil society, environmentalist views are represented through the institutionalised bureaucracy.



The book argues that theories of European foreign policy are performative: they create the objects they analyse. In this text, Henrik outlines the performativity

approach to the role of theories based on the work of Derrida and goes on to examine the performative role of Christopher Hill's concept of Capability-Expectations Gap in the study of European foreign policy. Through examples from relevant literature, Larsen not only demonstrates how this concept sets up standards for the EU as a foreign policy actor (that are not met by most other international actors), but also shows how this curtails analysis of EU foreign policy.

Australia's relationship with the EU has come a long way but room for improvement remains, including the absence of a formal trade agreement. Australian policymakers mustn't let Brexit delay closer EU-Australia ties.

Australian thinking and policy on European integration has, from the outset, been driven by two convictions: first, that the fundamental objectives of the European project are sound and in Australia's broad interests; second, that an 'open' version of regional integration would best suit Australian economic interests.

The first of these usually prevails as a priority, and the second is responsible for much of the noise and trouble in the history of the bilateral relationship.

# EU reaction to US withdrawal from Paris Agreement

After the announcement by US President Trump to withdraw from the Paris Climate Agreement and his intention to negotiate a new deal, the European Union refused outright to engage with the US in such negotiation, and decided to deal directly with US states and corporations, many of whom stated they intended to adhere to the terms of the agreement. President of the European Council Donald Tusk declared President Trump's withdrawal a mistake but said action on climate change would continue with or without the US. In a joint press conference with the Chinese Prime Minister, Li Keqiang, after the EU-China summit, Tusk declared:

'Strong transatlantic ties are far more important and far more durable than the latest unfortunate decisions of the new administration... China and Europe have demonstrated solidarity with future generations and responsibility for the whole planet'. The latter statement is a reference to a joint EU-China statement promising further action on global warming which includes raising \$100bn a year by 2020 to help poorer countries cut emissions.

The Chinese Prime Minister told reporters that China believed in abiding by international rules.

## The Rise of the National Front: Understanding Le Pen's Success in the 2017 Presidential Election

This is a research paper by ANUCES Intern Tanya Ma. Tanya presented this paper in May at the European Studies graduate workshop in Hanmer Springs, New Zealand, hosted by the University of Canterbury. Her paper was very well received.

# Excerpt from research paper by Tanya Ma:

This paper outlines three key factors in Marine Le Pen's successes in the 2017 presidential election, that is, Le Pen's achievement of attaining the highest voter numbers and percentage to date for the National Front in an election.

The first is the National Front's long-term strategy of appealing to ethnonationalism and politicising immigration to gain party support. This strategy has proved effective across regions in France with highdensity unemployment rates and lower income groups. Politicising immigration has been successful in creating concerns about terrorism and insecurity as major deciding factors for citizens' votes in the election.

The second prominent factor in Le Pen's success is her continual attempt to distance herself and the National Front from negative labels and its infamous legacy associated with her father, Jean-Marie Le Pen. Le Pen's attempts to reshape the party by using

progressive rhetoric simultaneously with attacks on immigration have mobilized greater support for her campaign and policy proposals.

The main external factor that played a part in contributing to Le Pen's voter base is Hollande's and Fillon's political fall-back before the election in 2017 that dropped large numbers of the support base for the Republicans and the Socialist Party, and assisted Macron and Le Pen in gaining more votes in the first round of the election. Similarly, the high abstention in the second round of the election assisted Le Pen's high vote percentage.

The first of the outlined factors in the French case aligns with those identified in existing literature on the rise of radical right-wing political parties. However, the second strategy used by Le Pen to reshape the party as more progressive in order to mobilise national security policy against immigrants is a technique not yet considered by existing theories.

The third factor is specific to the 2017 presidential election in France, but nevertheless suggests a correlation between public disillusionment with mainstream politics and the rise of radical far-right parties.

## Dates to watch for the remainder of 2017

Excerpt from Policy Note Issue 1 by Nicholas Simoes da Silva

**11 September 2017** – Norwegian parliamentary elections. Norway is not a member of the European Union, and its election is likely to be more innocuous than the other elections of 2017. The centre-right Conservative Government has been in power since 2013, having been preceded by 8 years of a Labour-led left-wing coalition.

**September 2017** – Nation to watch: Spain. The President of the Spanish state of Catalonia has pledged to hold an

independence referendum, despite intense opposition and threats from the Spanish Government. This second referendum, which according the President will be 'legal and binding', comes after a 2014 consultative referendum in which a large majority of Catalonians voted in favour of secession.

**October 2017** – Czech parliamentary elections, based on multi-member constituencies with open-list proportional representation. Watch to see how well Eurosceptic parties do in a country that once was among the strongest supporters of the European Union and yet in which support has dropped significantly.

**Late 2017** – German parliamentary elections, based on half of members being elected in single-member constituencies on first past the post and the rest elected by proportional representation based on party lists. German Chancellor Angela Merkel declared she will contest the election again. Merkel is regarded as key to stability in Europe and the EU but her handling of the migrant crisis has damaged her popularity in Germany. Expect to see a swing against her party, the conservative Christian Democratic Union (CDU/CSU).

The selection of former European Parliament President Martin Schulz as the SPD candidate may also shift the race. He is regarded as being more able

to criticise Merkel's leadership, as he was never part of the Grand Coalition, and he is untainted by domestic failures. A key party to note is the far-right Alternative for Germany (AfD), running on an anti-immigrant and refugee platform, with Eurosceptic undertones. Having fallen short of the 5% threshold for representation in 2013, the AfD looks set to break into the Bundestag with around 10-15% of the vote.
