

The Foreign Policy Council "Ukrainian Prism" is a leading Ukrainian nongovernmental, bipartisan think-tank with robust expertise on foreign and security policy (http://prismua.org/en/). PrismUA consists of 10 study programs covering all functional and geographical directions of Ukrainian foreign policy. Annually, the expert team produces a unique and comprehensive assessment of Ukrainian foreign policy under the authentic methodology.

The Foreign Policy Council "Ukrainian Prism" was officially registered as a nongovernmental organization in 2015, while analytical work and research had been carried out within the network of foreign policy experts "Ukrainian Prism" since 2012. At present, the organization united more than 30 experts in foreign policy, international relations, and international security, as well as associated experts from different analytical and academic institutions in Ukraine and abroad.

In 2023 the office of the "Ukrainian Prism" in Brussels was launched to extend outreach for in-house expertise to European governments and EU institutions.

Experts of the organization take part in the intersectoral task forces, working on the strategic framework of Ukraine in the foreign policy and security domain. The team's members contributed to the Foreign policy strategy of Ukraine, the Navy Strategy, the Public Diplomacy Strategy, the NATO Communication Strategy, MFA's strategy for Asia, etc.

The Foreign Policy Council "Ukrainian Prism" implements several projects to increase the level of foreign policy expertise in Ukraine, consolidate international support for Ukraine and raise awareness of foreign experts, politicians, and journalists about the events in Ukraine. "Ukrainian Prism" implements numerous projects on preparing analysis and recommendations for the Parliament of Ukraine, the Office of the President, the Vice-Prime Minister of Ukraine, the Ministry of Foreign Affairs, and other governmental and military structures in Ukraine.

"Ukrainian Prism" is one of the leaders in implementing innovative practices of expert diplomacy. In particular, jointly with the Ministry of Foreign Affairs and the Public Council under the Ministry of Foreign Affairs, it implements the concept of bilateral expert forums with partner EU states to discuss potentially sensitive issues. In 2022 Ukrainian Prism initiated a global partnership project covering Asia and Latin America. To fill in the information gaps in awareness about Ukraine, "Ukrainian Prism" organizes the visits of journalists from foreign states to Ukraine. Our experts regularly contribute to international media, including BBC, Al-Jazeera, TRT, France24, etc.

She specializes in European and Black Sea security, with a particular focus on Ukraine, Türkiye, and Russia.

Prior to joining the Marshall Center, Dr. Gaber worked as a foreign policy advisor to the Prime Minister of Ukraine (2021) and Deputy Director of the Diplomatic Academy at the Ministry of Foreign Affairs of Ukraine (2018 - 2020), where she was responsible for developing institutional cooperation with international partners and designing leadership seminars for diplomats and policy-makers in the defense and security sectors. She previously served as a diplomat in the Embassy of Ukraine in Ankara (2014 - 2018).

Dr. Gaber's more than 15 years of academic experience includes serving as Assistant Professor at the International Relations Department of Odesa National Mechnikov University (2009 - 2014) and most recently, teaching graduate courses on Black Sea security as a Visiting Professor at the Norman Paterson School of International Affairs in Carleton University, Canada (2022).

Dr. Gaber is a GMF Marshall Memorial Fellow, as well as a nonresident Senior Fellow at the Center in Modern Turkish Studies, Carleton University. She is widely published and is a frequent speaker at the diplomatic and defence academies across Europe.
