## About the network

The Policy, Politics, Culture: EU Migration and Integration (PPCEUMI) Network is focused on the study of third-country migrant integration in the European Union through the lenses of politics, policy, governance and culture.

PPCEUMI is concerned with the analysis of policy and governance reforms based on explorations of existing EU approaches and the experiences of third countries such as the USA, Singapore, Australia and New Zealand. It provides a comprehensive avenue to improve the EU and its member states' implementation of best practice.

Policy- and solution-oriented, PPCEUMI focuses on the immediate period of pre- and point of arrival of migrants, as well as the longer-term process of integration.

The network will explore the politics of migration and integration, including the role of NGOs, the drivers of migration and integration, and the larger context of international mobility.

PPCEUMI will also analyse and propose policy and governance reforms based on explorations of existing EU approaches and the experiences of third countries in integrating migrants.

Lastly, the project will examine the role of culture, citizenship and civic engagement, evaluating the models of assimilation and multiculturalism in the EU and third countries, and the role of education.
